So what is the Legal Tech Audit?

The legal tech audit is a basic tech skills competency test.

- Designed by Casey Flaherty of Kia Motors, Inc.
- Used to asses the tech skills of firm associates
- Should be done in 1 hour (or less) to "pass"
- Firms that took the audit needed 2.5 to 8 hours!
- Provides mock assignments for EXCEL, PDF, WORD

Why PDFs? Why Adobe Acrobat Pro?

- PDFs are the standard for filing and exchanging docs in the legal setting
- Can be read on virtually all devices making them universally compatible
- Ensures work looks right when printed by others or viewed on someone else's screen
- Secures your files from others copying or editing content, and even opening, printing or adding pages
- Protects your products (such as contracts and wills), verifies integrity of litigation documents, and more...

Adobe Acrobat Pro Tools to Remember:

- From Word to PDF (and back again) In both programs go to "File" > "Save As" -> "PDF" or "Word"
- Editing Text & Objects "Tools" -> "Content" -> "Edit Text & Objects" -> "Edit Text / Object"
- Adding/Extracting/Removing Pages "Tools" -> "Pages" –> "Delete / Extract / Replace / Insert"
- Multiple Files into a New PDF "File" -> "Create" -> "Combine Files into a Single PDF"
- Bates Numbering "Tools" -> "Pages" -> "Edit Page Design" -> "Bates Numbering" -> "Add / Remove"
- Adding/Editing/Removing Links "Tools" -> "Content" -> "Add or Edit Interactive Object" -> "Link"
- Sanitizing a Document "Tools" -> "Protection" -> "Hidden Information" -> "Sanitize Document"
- Encrypting PDFs "Tools -> "Protection" -> "Encrypt" -> "Certificate / Password"
- PDF Fillable Form "Tools" -> "Forms" -> "Create" -> "Use the Current Document" (x2) -> "Tasks" -> "Add New Field" -> "Text Field / Check Box / Radio Button / Digital Signature"
- Signing a PDF "Tools" -> "Sign & Certify" -> "Sign Document" -> draw box -> "Sign As: New ID" -> "New Digital ID...Create Now" -> "Name / Email" -> "File Name / Password" -> "Password" -> "Sign"
