All students pay regular tuition and a program fee. The program fee for the 2014 program was \$7200. While the exact amount of the 2015 fee will depend on variables such as costs, enrollment, and exchange rates, we anticipate it being substantially similar to that charged in 2014. A required application deposit fee of \$200 will be assessed from your UGA student account by the Bursar's Office after you have accepted admission to the program. One hundred dollars (\$100) of the deposit is refundable if you have been accepted to the program and withdraw from the program by August 19, 2014. A second deposit of \$1000.00 is due by September 5, 2014. The balance of the program fee will be due in December 15, 2014. Amounts paid in addition to the \$200 are not refundable. The University of Georgia School of Law reserves the right to cancel this program in the event of compelling circumstances. All monies, including the \$200 deposit, would in such event be returned within twenty (20) days of the date of cancellation and the law school will make its best efforts to arrange for the student to attend a similar program, if the student wishes, and to the extent feasible.
