



## Sample Bequest Language

Below is sample language to aid you and your attorney in preparation of your estate documents.

### **Bequest for Unrestricted Purposes:**

I give, devise, and bequeath to the UNIVERSITY OF GEORGIA FOUNDATION ("Foundation"), a non-profit corporation duly existing under the laws of the State of Georgia and located in Athens, Clarke County, Georgia, % of estate or \$ amount, as an unrestricted gift to benefit the Law School at the University of Georgia.

### **Bequest to Benefit an Existing Fund:**

I give, devise, and bequeath to the UNIVERSITY OF GEORGIA FOUNDATION ("Foundation"), a non-profit corporation duly existing under the laws of the State of Georgia and located in Athens, Clarke County, Georgia, % of estate or \$ amount, for \_\_\_\_\_ (Fund Name Here) \_\_\_\_\_ to benefit the Law School at the University of Georgia. Should circumstances later render it impossible or impractical to use this gift for the purpose herein designated, then the University of Georgia Foundation in consultation with the Dean of the Law School may use the gift for other purposes, adhering as closely as possible to my original intent.

### **Bequest to Create a New Endowed Fund\*:**
