Payment Information for the Georgia Law Summer Program in Brussels and Geneva 2014

Summary of Fees*

- **\$300** Non-refundable application fee;
- Approx. \$2250 University of Georgia tuition and fees see the J.D. in-state rate for Summer 2014 at: <u>http://www.reg.uga.edu/tuition</u> and technology, green fee, and institutional fees. Final rates are set in late April; tuition rates quoted earlier may be subject to change.
- \$1400 Georgia Law Summer Program in Brussels & Geneva program fee, see: <u>http://www.law.uga.edu/bg-tuition-fees-and-other-costs</u> for a breakdown of what is covered by tuition and fees;
- Additional \$250 for visiting students (this fee is waived for Georgia residents, students who attend a law school in the University System of Georgia, and students at SEC member institutions). This fee is charged in lieu of higher out-ofstate tuition rates, since "visiting" students in UGA study abroad programs are charged in-state tuition rates rather than out-of-state rates.

*In an unlikely situation, exchange rate fluctuation and/ or inflationary conditions may necessitate that the program raise fees above previously advertised rates between the time of admission and the beginning of the program.

Billing

Tuition and applicable fees will be billed directly through the online UGA Student Accounts System. A student account will be set up for non-UGA "visiting" students and instructions on how to access the account will be sent by email. The application fee (\$300) is <u>due</u> <u>immediately</u>. *Full payment of tuition and all applicable fees is due no later than April 30, 2014.* Each student is responsible for checking his/her student account and making payments in a timely manner.

Cancellation, Withdrawal, and Reimbursement Policies

The University of Georgia School of Law reserves the right to cancel for insufficient enrollment or under extraordinary circumstances such as natural disaster, war, political instability or emergency. In such an event, students will be notified by email and receive a full refund, including the deposit, within twenty (20) days after the cancellation. If requested, the program director will use best efforts to arrange for applicants to enroll in a similar program.

If changes in the course offerings or other significant aspects of the program occur, or if, during the course of the program, a U.S. State Department Travel Warning or Alert is issued for either of the countries in which the program is being conducted, students will be notified promptly personally or by email and given an opportunity to withdraw from the program. Applicants who have paid a deposit or registered for the program and withdrawn under any such circumstances will be refunded fees paid except for room and board payments utilized prior to the date of withdrawal or termination.

If a student withdraws voluntarily from the program after April 2, 2014, he or she is still responsible for paying unrecoverable program costs. Voluntary withdrawal includes withdrawal for academic or conduct reasons. If a student is dismissed from the program for academic or conduct reasons after the program begins, there will be no credits issued to the student accounts for fees that have been charged to the account.
