If I am selected to enroll in the Practicum in Animal Welfare Skills (PAWS), I hereby commit to doing the work required to meet the practicum's objectives in a professional manner. I understand that:

- I will need to spend a minimum of 125 hours during the semester on practicum work, as well as preparing for and participating in the weekly seminar, and this work will not be spread evenly throughout the semester and may involve weekend work;
- I will need to provide my own transportation to off-campus locations in the Athens area that may not be available from public transportation or within easy walking distance of the campus;
- I may be exposed to acts of cruelty or severe neglect or be involved in high conflict situations and am prepared accept the emotional consequences to me of this exposure; and
- participation in law enforcement activities brings with it inherent risks and these risks are elevated when dealing with nonhuman animals.

I agree to transition any open matters I may have at the end of the semester to students enrolled in PAWS in a subsequent semester or the professor.

Please attach a file with your typed answers to the following questions. It should be no longer than one page in length (12 pt Times New Roman font; 1” margins).

1. Why would you like to enroll in PAWS?
2. What experience have you had that you believe would make your participation in PAWS valuable to the animal welfare community and to other students in the practicum? (This could be experience in animal welfare, working with community members to come into legal compliance or prosecuting those that fail to do so, working closely with people who have socio-economic backgrounds that differ from yours, or anything else you think might be relevant.)
3. Two of the more difficult parts of animal welfare work are (1) emotionally dealing with acts of cruelty or severe neglect, and (2) remaining professional in confrontational settings (for example, in field reviews of potential violations and arraignments). Do you believe you will be able to handle these situations and why?
4. This practicum is a one-semester course for 4 credits (it may be taken for more than one semester if you and I agree it would be productive). I expect you to work 125 hours over the course of the semester (an average of approximately 9 hours per week) on practicum matters as well as prepare for and participate in the seminar and two full-day workshops. This work will not be distributed evenly throughout the semester; there will be more or less work than the average in any given week depending on workflow demands and you may be required to perform some work on weekends. Moreover, while some of the field sites are located downtown, others will be in areas of the community that are not easily accessible by public transportation or walking (including Athens-Clarke County Animal Control). Will you be able to participate fully in the practicum given these requirements? Please explain.
5. Please provide the names of two UGA professors you have had for class or for whom you have worked; I may contact one or both as a reference for you. If you have had me in class, you need only provide the name of one other professor. (Please note: If you are a law student, these professors must be in the law school; if you are not, please let me know in which school or college each professor has an appointment.)
6. I strongly recommend you do not enroll in another clinic, practicum, or externship while enrolled in PAWS. However, I do not prohibit it. If you wish to engage in another clinic or externship during the semester in which you are applying to PAWS, please indicate the other opportunity you would like to pursue, when it would occur, and where it is located. Please explain why you think you will be able to manage your time effectively between the two competing obligations, given the demands of law school more generally.
