

How to Update a US Code Section Online

Although the Code can be accessed via a variety of portals, this example begins with Cornell's LII site (www4.law.cornell.edu/uscode):

1. Access the code section by entering the US Code citation;

Find US Code Materials by Title and Section

If you know the citation for the US Code material you want to find, fill in the title and section numbers below. (e.g. 22 USC 1501 would be Title 22, Section 1501). You need to fill in both title and section.

and is the best information about currency we can obtain from the GPO system; it may not be very helpful.

There may be a more up-to-date version of this section at the GPO. You may also get a list of bills that mention this section from the Thomas system at the Library of Congress.

For a number of reasons you may want to check for updates manually. It is possible that the GPO server is down or busy, or that the update service offered by GPO is itself out of date.

UPDATING A SECTION MANUALLY

To determine if particular section has been amended you need to inspect the so-called "classification tables" prepared by the Office of the Law Revision Counsel of the House of Representatives. These map recently-passed laws and amendments to the Code to the particular sections of the Code that are affected. You can find them at the House server. Using the title and section of the Code that you are interested in, look through the tables sorted by Code section. Write down any of the Public Law numbers that affect the section you are interested in.

4. Go to uscode.house.gov, and then load the Classification Tables:

The Office of the Law Revision Counsel prepares and publishes the United States Code, which is a consolidation and codification by subject matter of the general and permanent laws of the United States.



5. From the list, select the first one that post-dates the revision date on the GPO response, and choose the preferred format for the list (usually HTML):



United States Code Classification Tables

These tables show where recently enacted laws will appear in the United States Code and which sections of the Code have been amended by those laws. The tables sorted in Public Law order may be used to identify the sections of the Code affected by a particular law. The tables sorted in Code order may be used to determine whether a particular section of the Code has recently been amended. The tables only include those provisions of law that have been classified to the Code. The text of recently enacted laws may be found through the Library of Congress [Thomas](#) web site.

(a) In General.--Activities authorized by part A of title IV of the Social Security Act, and by sections 510, 1108(b), and 1925 of such Act, shall continue through June 30, 2004, in the manner authorized for fiscal year 2002, notwithstanding section 1902(e)(1)(A) of such Act, and out of any money in the Treasury of the United States not otherwise appropriated, there are hereby appropriated such sums as may be necessary for such purpose.
